#### 2. The road to the Xth EUROSAI Congress

SAIs go through tremendous changes in order to play an active role in public sector audit. This requires SAIs to be equipped with advanced audit, analysis, reporting and communication skills, which cannot solely be fulfilled by traditional audit methods.

Accordingly, the demand for a stronger role for SAIs is also apparent in the latest standards and other documents published by INTOSAI. Furthermore, 69th United Nations (UN) General Assembly adopted the Resolution for "Promoting and fostering the efficiency, accountability, effectiveness and transparency of public administration by strengthening supreme audit institutions" on December 2014. The Resolution aims to urge Member States to give due consideration both to the independence and capacity-building of their SAIs, as well as the application within their regulatory frameworks of the principles of the Lima and Mexico Declarations. It is also worth mentioning that UN 2030 Agenda for Sustainable Development recognizes repeatedly the important role of SAIs in the implementation of the Sustainable Development Goals.

Undoubtedly, technical, organizational and professional competencies and excellence of an SAI are crucial to carry out its work with a view to contributing to good governance, transparency, and accountability. In this respect, the adoption and implementation of appropriate and effective professional standards are the key factors for promoting strong and independent SAIs.

Last but not the least, EUROSAI's common mission stated in the strategic plan for 2011-2017 is to strengthen public sector auditing in the region; thereby contributing to the work of INTOSAI.

We are now following up these discourses by asking how ISSAIs can be further improved in order to best serve to the credibility and quality of public sector auditing. Apart from discussing the issue from the theoretical perspective of ISSAI framework, we also intend to focus as much as possible on the practical examples of success and failures of implementation.

#### 3. Expected results and impacts

Beyond any doubt, the impact of the Congress will be remarkable if we are able to communicate our ideas and practical experiences for adding value. We hope both the Technical EUROSAI and the Congress will identify the EUROSAI members' diverse approaches on ISSAI implementation with regard to their independence, mandate and national legislation. Besides, we aim to establish an environment which gathers the related parties together and create an opportunity for discussion and brainstorming. In this respect, conclusions and recommendations declared at the end of the Congress will provide precious inputs for the further improvement of ISSAI framework by INTOSAI.

We welcome all suggestions to strengthen the impact of the Congress and all the support you may offer in the coming days.

We believe that the Congress is a deliberative process out of which the ultimate consensus will emerge.

This is our collective effort towards strengthening SAIs and increasing the quality of audit work, and this is the invitation that the EUROSAI Congress 2017 is offering to the community of SAIs.

#### 4. How the theme will be developed?

#### Technical EUROSAI 2016

The preparation process of X<sup>th</sup> EUROSAI Congress will be launched by Technical EUROSAI, which will be held as a preparatory conference in **Ankara in 27-29 September 2016**.

It will serve as an interactive platform for auditors to make sophisticated and technical discussions on staff level. Technical discussions will be carried out through workshops, knowledge cafes, etc. and organized in a way that will best serve the members' needs and choices. Our main priority will be the establishment of an enabling environment for the exchange of ideas and experiences in an effective manner. By this way, practical examples reflecting the experiences of field work will be elaborated with respect to successes and failures.

We expect that the results of the technical conference will help identify the main challenges, needs and ready solutions regarding ISSAI implementation. As a result, the conclusions of the Technical EUROSAI will provide valuable inputs for the main EUROSAI Congress in May 2017.

Therefore, we would very much appreciate if you could send a delegation to the Technical EUROSAI conference in 27-29 September 2016.

We hope that the content of the conference/congress and issues to be discussed will be specified through the active participation of EUROSAI members. We welcome all sub-themes and a wide range of methods of presentation and discussion for both Technical EUROSAI and the X<sup>th</sup> EUROSAI Congress. In this respect,

What issues and sub-themes can be elaborated during the Technical EUROSAI in September 2016 and X<sup>th</sup> EUROSAI Congress in May 2017? The sub-themes would come from the areas that your SAI has a big say and makes a difference, or issues that you wonder about the practical solutions of a specific problem in terms of ISSAI implementation. We would like to kindly remind you that after having received your proposals for the sub-themes we will

formulate a shortlist of selected topics and ask about your participation as a moderator, facilitator or participant.

Here are a few intriguing topics for you. You can inspire from the issues listed below or think completely out of the box!

- ✓ How can standards and guidelines related to financial audit be reviewed to meet public sector needs and interests? Which types of audit being conducted in your SAI need further guidance with respect to ISSAI framework?
- ✓ Expected audit functions of an SAI beyond giving opinion on the financial statements, e.g. giving opinion on compliance and evaluating the effectiveness of internal controls.
- ✓ What are the areas and issues that are not fully covered or need further elaboration by the existing ISSAI framework, e.g. audit of consolidated financial statements of general government or its sub-sectors, audit of performance information, audit of contingent liabilities, or else.
- ✓ How can the conflicts between national jurisdiction and ISSAI requirements can be resolved?
- ✓ What are your success and failure stories in implementation of ISSAIs?
- ✓ And so forth...

Please feel free to submit all your suggestions about sub-themes without any consideration of delivering a presentation.

#### 5. Methods for presentation and discussion

All kinds of contributions from member SAIs will be welcomed. These may include, for example:

- Knowledge cafes (with brainstorming sessions and round table discussions);
- Workshops; and
- Plenary sessions with stimulating key note speakers;
   Or more informal ways of presentation can be chosen; such as:
- A poster presentation; and
- An "ideas market".

Which method do you believe serve best for accomplishing our ultimate goal? In which ways an enabling environment can be created for exchange of ideas and experience? We highly appreciate if you could share your opinions with us to facilitate the most nourishing and

creative platform possible.

By this way, we think that we can organize both events with necessary arrangements in a way
