2. **Results achieved** (to be included in the Progress Report of the relevant Strategic Goal/Portfolio): The workshop on long-term peer-to-peer capacity building was held in February 2019 in The Hague, organized by the SAIs of The Netherlands and Sweden, in cooperation with the INTOSAI Capacity Building Committee (CBC). It gathered over 20 participants from 8 EUROSAI members and the IDI. The project is completed. The findings of the workshop have been carried forward by the newly established CBC work stream on peer-to-peer cooperation (coordinated by The Netherlands).
