



11th Meeting Goal Team 4

SUMMARY OF AGREEMENTS

I. The **EUROSAI Goal Team 4 – Governance and Communication (GT4)** 11th meeting was held in The Hague on the 13 and 14 October 2016. The meeting focused on the finalization of the self-assessment report and the development of the strategic plan 2017-2023. For this reason also the members of the Governing Board attended the meeting.

So far, there are 59.382 euros	





			 available, which will be incorporated into the 2017 Budget if they are not spent by 31 December. ECA enquired about the possible uses of the welfare fund and whether an income approach (by reducing income) had been considered. The Secretariat/Spain pointed out that a Discussion paper on the financial situation of EUROSAI had been presented to the GB at its 44th meeting (item 6 of the agenda), in which the Secretariat/Spain invited the GB to reflect on a list of projects and decide which of them should be taken forward and financed by the EUROSAI Budget. The Secretariat/Spain also explained that the income approach had already been considered, but before considering this option the financing needs within EUROSAI had to be assessed, plus the need for having a buffer and the convenience of ensuring enough available funds for implementing the new ESP. GT2 announced that they will make a request for technical equipment of its meeting.

the way forward with the Magazine report	Spain	The Secretariat/Spain reviewed the recommendations from the Magazine survey, indicating which had already been implemented by the Secretariat/Spain. Since the GB entrusted the editorial board with the implementation of the recommendations included in the survey's report, those which could not be implemented directly by the Secretariat/Spain would need to wait until the Editorial Board was operative.
INTOSAI KSC-IDI online learning and communication		
platform in EUROSAI	Spain	 The Secretariat/Spain presented the information to start testing the KSCI-IDI portal. No formal agreement with IDI is needed and no cost is involved in the testing. A EUROSAI restricted area must be opened to set-up different functionalities (On-line meetings (using blackboard), Forum (using Moodle) Communities of Practice, Blogs, Surveys, E-Learning). Currently, videoconferencing is the most demanded and useful tool. For that, IT people must be trained by IDI to use videoconferencing tool. GT4 agreed to start the testing, giving priority to using blackboard for videoconferencing. Portugal will take the lead in the testing and marketing of the platform. The Secretariat/Spain will cooperate closely with them.



	Task Force on Audit and Ethics • the EUROSAI TF AE video competition	Portugal	 Portugal and Secretariat/Spain offered people to be trained. GTs were encouraged to use the videoconference tool when available. Discussion on the new EUROSAI strategic plan can be made using blackboard. 5 colleagues from Portugal and Spain are being trained. The NCA offers to train one employee. GT4 members will experiment with the portal up to the GB meeting in May 2017. The video competition price is not in money but in kind. The price for the winner – being an individual or a group of participants – could be: the participation in the Eurosai congress, training events or a study visit to a member SAI. On the other hand, the price for the logo is in money and most employees and SAI's are not allowed to receive money. This dilemma should be further discussed in more detail. The NCA suggests not restricting integrity to SAIs as an institute, but also integrity in audits and all other activities by SAIs.

However, since its percentages had to be recalculated with the information from triangulation, the Secretariat/Spain offered the Netherlands to do so and thus finalise the document. The Secretariat/Spain agreed to prepare also the Executive summary (making use of chapter 5 of the





			self-assessment), take into account the external scan (including INTOSAI RWG) Regarding dissemination of the full report, GT4 agreed that it will be available for all the members on request. Follow up: after the GB formally approves the report, the executive summary and a piece of news will published in the EUROSAI website.
